

Author's Guidelines

All manuscripts should be addressed to the Chief Editor, Vigyan Varta. Submission of an article implies that it has not been previously published and is not under consideration for publication elsewhere; and further, that if accepted, it will not be published elsewhere. Manuscripts of all categories are to be submitted through mail only vigyanvarta@gmail.com only.

Categories of Manuscripts

Popular articles, newsletters, meeting reports, success stories and any write-up relevant to a particular domain of science.

Manuscript Preparation Guideline

1. Manuscript must be original and any form of plagiarism must be avoided. In case of any breach, the authors will be responsible.
2. Manuscript must be written in a way that is easy for all the readers of all domains to understand.
3. The manuscript should be prepared in English using "MS Word".
4. Manuscript should be written within **2-4 pages**, **font size: 12, Times New Roman, Spacing: 1.5, and justify.**
5. Manuscript should have an introduction and conclusion. Abstracts and summaries along with maximum of **5 keywords** in the beginning are most preferred.
6. Tables and figures in proper format and citation are always encouraged.
7. A maximum of **4 references** must be included at the end of the article.

Reference

References should be kept to a minimum and listed in alphabetical order.

Personal communication and unpublished data should not be included in reference list. The list of reference at the end of the text should be in the following format. The authors are responsible for the correctness of references.

1. For Journals:

In the text, references should be cited as follows: two authors (Rath and Samal, 2016), three or more authors (Gupta *et al.*, 2017). Listing of references in the text should be chronological separated by semicolon, e.g. (Smith, 1985; John, 1998; Moriss *et al.*, 2001).

2. For Books:

Author, A.B., Author, B.B. and Author, C.C., year. Title of Book. Ed, Vol, Publisher, City, , page numbers.

e.g- Nadkarni, K.M., 2000. Indian Materia Medica. Edn 3, Vol. I, Popular Prakashan, Mumbai, pp:242-246.

3. For Website reference:

Author, A.B. (if any). Title. url

e.g- Slavtt, A. The Coronavirus Crisis Will Force Us to Reconsider Universal Health Care. url:<https://medium.com/@ASlavitt/the-coronavirus-crisis-will-force-us-to-reconsider-universal-health-care-d5e26380e744>.

Submission Procedure

- The Manuscript (in .doc or .docx format) must be submitted online to the email id: vigyanvarta@gmail.com
- After submission of the article the author will be provided with an **author agreement** form that he/she has to duly fill and submit to the same id.
- Once the articles are accepted, the publication will be done within a maximum period of 7 days.
- Any query will be addressed by the email id provided.

- There are no processing or submission charges. However, there is a nominal publication charge of Rs 200 per article.
